do hereby solemnly affirm, declare and undertake as follows:

1. I have enrolled my son/daughter Mr./Ms.....at **BODOFA UN BRAHMA SUPER 50+ MEDICAL COACHING**, A flagship project of Govt. of BTR, ASSAM for coaching of NEET (UG) Examination 2026.
2. That I have understood the complete rules and regulations of the program and have enrolled my child out of my own free will & that my child would not enroll with any other private or Government sponsored coaching.
3. That I would provide to the Department of Education, BTC, the complete details (photocopy of the admit card, Mark sheets, pass certificates, income certificate etc) and such other documents as desired for admission into the program.
4. I shall be responsible for the conduct and behaviors of my son/daughter/ward throughout the period of his/her stay in the accommodation provided by the Centre for undergoing the coaching. That Department of Education, BTC reserves the right to remove/expel my son/daughter/ward on the grounds of discipline, insubordination and non-performance in academics.
5. That in the event of expulsion of my /son/daughter/ward on any of the grounds as mentioned above from the course, I would be unconditionally liable to pay the entire course fee and other ancillary costs, such as travel, medical costs etc and also the cost of food & lodging from the date of starting of the course up to the date of such expulsion to the Department of Education, BTC.
6. I understand that my son/daughter/ward is being given free coaching including free boarding and lodging facility on the solemn assurance given by me on behalf of my son/daughter/ward that he/she shall sincerely and diligently pursue and complete the course in the format laid down by the Centre (ALLEN Career Institute Pvt. Ltd).In the event, my son/daughter/ward leaves the course in the middle or otherwise without completing the same in the manner planned by the coaching institute then I would be unconditionally liable to pay to the Department of Education, BTC the entire course fee including the cost of food & lodging from the date of starting of the course up to the date on which my son/daughter/ward leaves the course and also other ancillary costs, such as travel, medical costs etc. I undertake and agree to pay the same without any challenge or dispute.

7. That in case any other institution claims the name of my son/daughter/ward to have been associated with that organization for successful clearance then I would pay the complete cost spent by the Govt. of BTC on my child towards course fee, boarding and food including other ancillary expenses like travel cost etc made by the Department of Education during the entire coaching period commencing from the date of starting of the course.
8. That my son/daughter/ward is in good mental & physical health and is free from any chronic or contagious disease.
9. For those candidates who are awaiting their NEET (UG) results in the current year, will be given a relaxation period of upto two months from the date of joining in Bodofa UN Brahma Super 50+ Program within which if you qualify NEET(UG), then upon submission of official proof of the same, the candidate will be allowed to leave the coaching without paying any penalty. However, beyond two months' time if a candidate desires to leave the course, then the penalty in clause No 6. will be applicable.

TERMS AND CONDITIONS

1. The duration of this coaching is from May 2025 to April 2026 (11 Months).
2. The program is fully residential for all the selected candidates.
3. The complete coaching, accommodation and food is free.
4. Students would have to bring their own stationery.
5. The basic infrastructure like bed, mattress, study table, chair, almirah, curtains etc. would be provided at the centre.
6. Students are required to bring their own personal utilities of personal use.
7. Students would have to go through a rigorous training program through classes, mock tests etc. during the period of the coaching.
8. Parents would be allowed to visit the students only on some special occasions or in case of medical emergency.
9. There would be no holidays during the period of training.
10. Students would be provided tea, Breakfast, Lunch & Dinner as per a fixed menu.
11. Faculties would be teaching through direct classes as well as online classes (as & when required).
12. Students would not be allowed to go on leave for any other examinations other than NEET (UG) examination.
13. Students have to abide by the HOSTEL RULES AND MESS REGULATIONS. Management reserves the right to change the rules and regulations, terms and conditions as and when required.
14. Medical expenditure if any has to be borne by the candidate.
15. Local travel within Guwahati (including to & fro to the Centre from hostel) has to be arranged by the candidate.
