# ORDERS BY THE GOVERNOR

## NOTIFICATION

Whereas, vide Govt. Notifications (i) No. E-233475/272 dated 31/12/2022, (ii) No. E-233475/303 dated 06/11/2023, and (iii) No. E-233475/387 dated 21/09/2024 issued by the Welfare of Bodoland Department, 81 new villages were included in the Bodoland Territorial Region (BTR);

And whereas, the Rule 3 (2) of Bodoland Territorial Council (Election) Rules, 2004 mandates that the Government shall publish the draft delimitation order for general information in such conspicuous places in the council area as deemed necessary inviting view, objections or suggestions from all concerned within seven days from the date of such publication;

And whereas, the undersigned was delegated with the power of delimitation for determining the territorial limit of Constituencies to which the newly included villages in the Bodoland Territorial Region will be included, as per procedure laid in Rule 3(2) of Bodoland Territorial Council (Election) Rules, 2004, vide Welfare of Bodoland Department's Notification No.E-610598/125 dated 03/06/2025.

Now therefore, after due consideration of all aspects, the Governor of Assam is pleased to publish hereby the draft order for delimitation as detailed in Annexure-'A' for determining the territorial limits of BTC Constituencies in respect of the 81 villages included in the Bodoland Perstorial Region (BTR), as per Welfare of Bodoland Department's Notifications stated above.

Any views, objections or suggestions from individuals/organisations may be submitted to the respective District Commissioners on or before 13/06/2025. The District Commissioners shall . examine the submissions and forward the same along with their recommendations/observations/ comments to the undersigned on or before 16/06/2025.
