**ENTRANCE EXAMINATION FOR ADMISSION INTO POSTGRADUATE COURSES IN  
MPT/MMLT/M.OPTOM BOTH IN THE GOVERNMENT AND PRIVATE INSTITUTES OF ASSAM  
FOR THE SESSION 2025**


In pursuance of the Assam Gazette Notification No. MER. 206054/786 dated 07-11-2023 and Notification No. MER. 488929/19 dated 26-07-2024, Srimanta Sankaradeva University of Health Sciences is conducting an Entrance Examination on **27-07-2025 at Guwahati from 11.00 AM to 1.00 PM** for selection of candidates for admission into Postgraduate courses in MPT/MMLT/M.OPTOM in both the Govt. and Private Institutes of Assam for the session 2025. Application Forms shall be available on University website: **www.ssuhs.in**. The last date of submission of filled in Application Form at the Office of Srimanta Sankaradeva University of Health Sciences is **10-07-2025** during office hours.

Candidate must be a citizen of India and should have secured minimum 50% aggregate marks in qualifying examination and there will be 5% relaxation of marks for SC/ST candidates. Permanent Resident Certificate is mandatory for admission in the Govt. Institutes of Assam. There is no Govt. seat for MMLT and M.OPTOM courses. The distribution and reservation of seats shall be according to the directives of the Government of Assam.

A non-refundable examination fee of **Rs. 5000/- (Rupees Five Thousand only)** is required to be paid in online mode through the link available in SSUHS website (**Fee Collect – Student/ Applicant/ Candidate – FEES FOR PG ENTRANCE-MPT/MMLT/M.OPT**). They are to keep a print copy of payment receipt for further use and enclose a copy with the application form. Above Examination fee is exempted for PwD (Divyang) category of candidates.

The Entrance Examination shall consist of 50 (Fifty) Multiple Choice Questions containing 2 Marks each. There shall be no negative marking.

Applicants or their duly authorized persons will have to collect the Admit Cards from the Office of the Registrar, Srimanta Sankaradeva University of Health Sciences from **21-07-2025 to 25-07-2025** during office hours.

1. While filling up the Form, use capital letters only.
2. The candidates have to fill up the application form with blue / black ink in his / her own hand writing.
3. Application submitted without the signature of the applicant in the space provided will not be accepted.
4. A non – refundable examination fee of Rs. 5000/- (Rupees Five thousand only) is required to be paid in online mode through the link available in SSUHS website (Fee Collect – Student/ Applicant/ Candidate – FEES FOR PG ENTRANCE-MPT/MMLT/M.OPT) and a payment receipt shall have to be submitted along with the Application Form.
5. Enclose Photocopies of the following supporting documents.
  - a) Applicant must be a citizen of India.
  - b) Permanent Resident Certificate is mandatory for admission in the Govt. Institutes of Assam.
  - c) Admit Card/ Certificate of HSLC or equivalent examination (for age proof)
  - d) All Mark sheets and Certificates of qualifying Examination i.e. BPT/BMLT/B.Optom etc.
  - e) Caste Certificate from competent authority (wherever applicable)
6. Last date for submission of filled in Application Form is **10-07-2025 (upto 5:00 PM)** at the Office of Srimanta Sankaradeva University of Health Sciences, Narakasur Hilltop, Bhangagarh, Guwahati-781032, Assam.
7. Applicants or their duly authorized persons will have to collect the Admit Cards from the Office of the Registrar, Srimanta Sankaradeva University of Health Sciences from **21-07-2025 to 25-07-2025** during office hours.
8. The Entrance Examination shall be held on **27-07-2025 at Guwahati from 11.00 AM to 1.00 PM**
9. The minimum qualifying criteria/cut off score in the Entrance Examination will be as follows:
  - A. For Govt. Institutions (MPT):**
    - a) General (UR/EWS) – 30<sup>th</sup> Percentile
    - b) SC/ST/OBC (NCL)/ Divyang – 20<sup>th</sup> Percentile
  - B. For Private Institutions (For 50% Management Quota Seats) (MPT / MMLT / M. OPTOM):**
    - a) General (UR/EWS) – 20<sup>th</sup> Percentile
    - b) SC/ST/OBC (NCL) – 18<sup>th</sup> Percentile
    - c) Divyang – 15<sup>th</sup> Percentile
  - C. For Private Institutions (Rest 50% seats) (MPT / MMLT / M. OPTOM):**
    - a) General (UR/EWS) – 18<sup>th</sup> Percentile
    - b) SC/ST/OBC (NCL) – 15<sup>th</sup> Percentile
    - c) Divyang – 15<sup>th</sup> Percentile
10. There is no Govt. seat for MMLT and M.OPTOM courses.
