

FINAL RESULTS FOR UPSC 2025-26 AND GUIDELINES

(Please read the all instructions carefully)

1. The list of the candidates selected for the **Bodofa UN Brahma Super 50+ UPSC Coaching Programme** is enclosed below. Please refer to **Annexure I**.
2. The list of the candidates selected for the **Bodofa UN Brahma Super 50+ UPSC Coaching Programme** under **Community Reservation** is enclosed below. Please refer to **Annexure II**.
3. The final selection of the candidates has been carried out based on their performance in the Mains and Personal Interview, as assessed and evaluated by the Interview Panel.
4. All selected candidates must submit a notarised affidavit on a non-judicial stamp paper worth a minimum of ₹100/- at the time of admission, duly signed by the candidate and their parent/guardian. Please refer to **ANNEXURE III** for the format and details.

Important Guidelines:

1. All the selected candidates are required to deposit an amount of **₹93,500/-**, which constitutes **25% of the total expenditure** for the programme. This amount covers **coaching fees, PG accommodation, and food expenses (for 11 months)**.
2. Payment may be made via **UPI (QR Code)** or **Net Banking in the account details provided in ANNEXURE IV**. Please note that the amount is non-refundable. For further details, kindly refer to the Affidavit and Undertaking attached below.
3. All the Candidates must complete the payment **on or before 20th July 2025**.
4. The admission will remain **provisional** until the payment is received and verified by the Department.
5. **Failure to deposit the student contribution within the deadline will lead to suspension** from the course.
6. All the Candidates must submit their payment details, including **Transaction ID, Date of Payment, and Amount**, for verification through the following Google Form link:

do hereby solemnly affirm, declare and undertake as follows:

1. I have enrolled my son/daughter, Mr./Ms., in the **Bodofa UN Brahma Super 50+ UPSC Programme 2025–26**, a fully residential coaching programme supported by the Government of BTR for preparation of the UPSC Civil Services Examination (CSE) 2026.
2. I understand that this programme is mainly funded by the Government, but as parents/guardians, we are required to pay **25% of the total cost**, which includes coaching fees, food, and accommodation charges for 11 months.
I agree to pay this **within 1 month from the date of declaration of the Bodofa U.N Brahma Civil Services 2025-26 results**, and I will also submit **proof of payment** to the Department of Education, BTC.
I clearly understand that if I **fail to make this payment within the given time**, my son/daughter will be **debarred (removed) from the programme**.
3. I have read and understood the rules and conditions of the programme and I have willingly agreed to send my child. I also confirm that my child will **not join any other coaching institute**—whether government or private—during this programme.
4. I will submit all documents required by the Department of Education, BTC, including admit cards, mark sheets, certificates, income certificate, and others as asked.
5. I take full responsibility for the behaviour and discipline of my son/daughter during the entire coaching period, especially during their stay in the hostel.
6. I understand that if my son/daughter breaks the rules, does not perform well, or gets involved in any act of indiscipline, the Department of Education, BTC has the full authority

to suspend/expel the student from the coaching programme.

7. If my son/daughter is expelled for any reason mentioned above, I agree to pay the **remaining 75% of the cost**, which will include the coaching fees and monthly fees for food and accommodation, from the date of joining the programme till the date they were expelled.
8. If my son/daughter leaves the coaching on their own before completing the full duration, I will still be responsible for paying the **remaining 75% of the total cost**, along with food, lodging, and other expenses.
9. I declare that my son/daughter is in good health and does not suffer from any serious or contagious illness.
10. For those students waiting for results of **UPSC (CSE)** or **APSC (CCE)**, a **grace period of two months** from the date of joining will be given. If the student qualifies and gives proof within that time, they can leave the coaching **without paying any penalty**. However, if they leave after two months, the penalty under Point 8 will apply.

TERMS AND CONDITIONS

- Coaching will be held from **July 2025 to June 2026**.
- It is a **fully residential programme**—all students must stay at the officially arranged hostel/PG only.
- Coaching, food, and stay are **provided free of cost** by the Government, except for the 25% contribution from parents.
- Students must bring their **own stationery and personal items** (toothbrush, bucket, mug, bed sheet, towel, etc.).
- Hostel will provide basic items like **bed, mattress, table, chair, curtain**.
- Coaching will be **intensive**, with daily classes, tests, and practice.
- **No holidays** will be allowed, except in special cases.
- Students can only appear for **UPSC (CSE)** or **APSC (CCE)** exams during the programme.
- Parents may visit only on special occasions, Sundays or in case of emergency.
- Hostel and mess rules must be followed strictly.
- Any **medical expenses** during the tenure of the coaching programme must be paid by the student or parent.
