KEY DECISIONS

Financial Approval to Eti Koli, Duti Paat

- ▶ Cabinet has approved financial sanction of ₹342cr for implementation of Mukhya Mantri Eti Koli, Duti Paat Scheme
- ▶ The amount will be disbursed in a single instalment of ₹5,000 per eligible beneficiary to around 7 lakh workers and employees



Fructifying Advantage Assam 2.0 proposals

- ▶ Cabinet has approved allotment of land at Sarusajai in Guwahati for building a 500-bed Medanta Hospital, a 100-bed Women and Child Hospital and a 5 star Lemon Tree Hotel
- ▶ The combined investment of the three projects is ₹800cr and will create around 2,700 jobs for local youth



Inclusion of employees under MMLSAY

- ▶ Cabinet has approved the inclusion of willing employees and dependents of Assam Power Distribution Corporation Ltd, Assam Electricity Grid Corporation Ltd, Assam Power Generation Corporation Ltd and Adarsha Vidyalaya under Mukhya Mantri Lok Sevak Arogya Yojana (MMLSAY)



Teachers Quarters and Students' Hostel in Assam Medical College and Hospital

- ▶ Cabinet has approved a project to build Teachers Quarters and Students' Hostel in Assam Medical College and Hospital worth ₹357.28cr
- ▶ The project will include Staff Residence, Hostel, Dining Block, Community Hall, etc.

Setting up of National University for Disability Studies

- ▶ Cabinet has approved allotment of land and waiver of premium to Ministry of Social Justice and Empowerment for setting up of a National University for Disability Studies



Boosting Hydrocarbon Exploration and Production

- ▶ To streamline the process of land availability for hydrocarbon exploration & production activities, Cabinet has approved notifying exemption of hydrocarbons exploration and production activities from the purview of "The Assam Regulation of Reclassification and Reclassification cum Transfer of Lands Act, 2015" subject to the payment of the applicable premium
- ▶ Companies have been permitted to purchase or lease the required land directly from landowners through negotiated settlement, as per prevailing market rates and applicable guidelines



Allotment of land under Mission Basundhara 3.0

- ▶ Cabinet has approved allotment of Govt land under Mission Basundhara 3.0 to
 - 336 infrastructure projects of State Govt
 - 45 infrastructure projects of corporations, boards, etc.
 - 3,247 non-individual juridical entities
 - 28 Central Govt departments and undertakings
