B.A.,LL.B./B.A.,LL.B.(Hons.)(Five-Year Integrated): Applicants should have passed the 10+2 or equivalent exam from a recognized board with a minimum percentage of marks not below 45% of the total marks in case of general category applicants, 42% of the total marks in case of OBC/MOBC category applicants and 40% of the total marks in case of SC, ST category applicants.

LL.B.(*Three-Year*):A degree (graduation) in any discipline or any equivalent qualification from a recognized University with a minimum percentage of marks not below 45% of the total marks in case of general category applicants, 42% of the total marks in case of OBC/MOBC category applicants and 40% of the total marks in case of SC, ST category applicants.
