A. Age: A candidate should not be less than 18 years and should not be more than 30 years of age as on 01/01/2025. The upper age limit is relaxable for the candidates of reserved categories as per the existing prevision. However provision for condonation of age.

Age Relaxation: Upper age limit is relaxable as under:

03 (three) years in case of candidates belonging to OBC/MOBC.
 05 (five) years in case of candidates belonging to SC, ST (P) & ST (H)

For determining the age limit, the Department will accept only the date of birth recorded in the Matriculation or equivalent examination Certificate/Admit card issued by a recognized Education Board.
